Lexington Council Garden Clubs is pleased to share with you information for applying for funds from proceeds of the June 2017 OPEN GATES TO BLUEGRASS LIVING GARDEN TOUR. Attached you will find an application form.

To be considered for funding, the project must meet the following criteria:

1. Must be in Fayette County, except for projects at GCKY State Headquarters.
2. Must not be for private use or operated for profit.
3. Must be in line with the following purposes of the Lexington Council Garden Clubs:
 - a. Aid in the protection, enhancement, and conservation of natural resources and civic beauty.
 - b. Stress will be on the use of native plants. No invasive species allowed.
 - c. Advance the art of gardening, floral design, landscape design, and the study of horticulture.
 - d. Further horticulture education, conservation, and landscape design through scholarships.
 - e. Continue restoration and maintenance of designated historic shrines and State Garden Club Headquarters.
4. Approved funds shall be used within twelve months of date of approval or a written request for extended date submitted to the LCGC President, Karen Angelucci. Once a project is approved, a designated LCGC member will monitor the project and provide written reports on the status of the project to the LCGC.

PROCEDURE:

1. Submit one copy of typed application form by March 9, 2018, to grant committee chair:

2. Separate applications must be submitted if more than one request is made.
3. Limit information to the application form. One additional page (8 1/2 X 11) may be used for pictures (only one copy needed).
4. A selection committee of five LCGC members appointed by the President shall review the applications and prioritize.
5. Committee members will conduct interviews and/or visit sites, as needed.
6. Based on the total amount of funds available, the selection committee will recommend projects for consideration to members of LCGC.
7. Upon majority recommendation of LCGC members, the proposed projects will be presented to the membership of the clubs comprising the LCGC for their approval. Each of the seven clubs has one vote.
8. The project applicant will be informed of the approval or non-approval of their request by April 27, 2018.
9. After the project is started, the designated Garden Club member shall send a written report on the status of the project and a written report on the completion of the project (within 12 months of the start date) to the LCGC President:
